## **DISCRIMINATION COMPLAINT POLICY**

Title VI of the Civil Rights Act of 1964 (42 United States Code §2000d) and Tennessee Code Annotated § 4-21-904 provide that any entity receiving Federal financial assistance may not discriminate against their program applicants, beneficiaries or participants based on their race, color or national origin. Further, the Tennessee Human Rights Act (Tenn. Code Ann. §§ 4-21-601) provides for fair housing based on race, color, creed, religion, sex, handicap, familial status or national origin.

The City of Erin does not discriminate against any person based on race, color, national origin, gender, religion, disability, age, creed, familial status, or any other basis legally prohibited by or protected by Federal or State Law.

If you feel that you have been discriminated against because of your race, color, national origin, sex/gender, disability, religion/creed, age (40 or over) or familial status\* (presence of children or pregnancy) then you may file a complaint with the City of Erin. All complaints, written or verbal, will be accepted.

Complaints of discrimination must be filed with the City of Erin within 180 days of the alleged discriminatory act.

Complaint information shall minimally include the following items:

- 1. Name, address, and phone number of the complainant.
- 2. Name and location of the city entity delivering the service.
- 3. A description of the incident that led the complainant to feel discrimination had occurred.
- 4. The basis of the complaint (race, color, or national origin) must be stated.
- 5. Names, addresses, and phone numbers of other persons who may have knowledge of the alleged discrimination.
- 6. The date or dates on which the alleged discrimination occurred.

The City of Erin will notify you of the receipt and status of your complaint within 7 working days of receiving the complaint. Where appropriate, a complaint investigation will be completed. A written response to your complaint will be sent to you within no more than 7 working days.
